1	<p>The total number of sections of Bal Vatika shall be restricted to 06 (02 section each for Bal Vatika 1, 2 and 3 respectively). The total number of sections from classes I to X shall be restricted to 16. In the rooms between 400-500 Sq.Ft, the enrollment to be restricted to 32 students per section. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq. ft. dimension. In the rooms of size greater than 500 Sq.Ft, the number of students in each class shall be restricted to 40.</p>
2	<p>The School is required to construct additional classrooms as per prescribed dimensions, as school has only 05 classrooms of size greater than or equal to 500 Sq.Ft., and submit compliance on SARAS Portal.</p>
3	<p>The fire safety certificate uploaded on SARAS portal was valid up to 15.12.2023 only. School shall obtain the renewed fire safety certificate from the appropriate authority and submit compliance on SARAS Portal.</p>
4	<p>School does not have minimum number of indoor games, as per board's SoPs. Thus, the school shall upgrade its all sports infrastructure and also to have adequate and latest indoor sports facilities, as per Board's SoPs within 03 months and submit the compliance with videography.</p>
5	<p>Ramp/lift to access upper floors is not available in the school. School shall make provision of ramp/lift for accessing the upper floors, as per provisions of RPwD Act, within 03 months and submit the compliance with videography.</p>
6	<p>The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. The signage (Disabled) is erroneous and objectionable. It should be CWSN toilet for girls/boys. Instead of grab bars on both sides of WC, as mandated, a single rod is affixed on one side, whereas there is no grab bar on the other side of the</p>

WC. The building is G+1, but only 1 CwSN toilet each for boys and girl seen in the review inspection video. School does not have any CwSN toilet on the first floor. The School shall construct CWSN toilets separately for boys and girls on every floor with proper permanent signage, indicating the floor number and with all infrastructural facilities, as per norms of RPwD Act and guidelines of the Board within 03 months and submit the compliance with videography.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws- 2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
